MINUTES

June 19, 2019

The Pledge of Allegiance to the flag was recited by everyone who was in attendance.

CALL TO ORDER

The meeting of the Hebron Town Council was called to order at 7:02 p.m. by President Rick Dwyer, with Commissioners Ronald Ayers, David Hooper, Chester Sebald and Amelia Handy in attendance. Commissioner Ayers opening comments included the abundance of flies and the low hanging branches over the sidewalks.

MINUTES

The minutes of June 5, 2019 were presented. Commissioner Hooper made a motion to approve the minutes as presented. The motion was seconded by Commissioner Ayers. The motion was passed unanimously.

POLICE REPORT

The May Activities Report from the Wicomico County Sheriff's office was reviewed.

BUILDING PERMITS

None to report.

OLD BUSINESS

- 1) 7:15 PUBLIC HEARING was held. Commissioner Dwyer summarized there was no increase in fees or taxes. After discussion Commissioner Sebald made a motion to approve the Town of Hebron's FY20 Budget as presented.

The motion was seconded by Commissioner Hooper and all voted in favor which concluded the public hearing portion of the meeting.

- 2) Maryland Department of the Environment (MDE) Drinking Water Revolving Loan Fund – Commissioner Dwyer announced the Town of Hebron’s request for funding of a second water tower had been reviewed and that an additional water tower may result in insurance rating improvements. A workshop is planned for July 17, 2019 at 6:00 pm for the Engineer to present the specifics and progress of the project.
- 3) Ordinance #67 was discussed. Attorney Cox presented a draft of the First and Second notices to the Commission for review. Attorney Cox to resubmit edited notices incorporating suggestions discussed.

NEW BUSINESS

- 1) Carbonite File Back Up renewal was discussed and a more robust version was suggested by staff. A motion to renew for one year with enhanced capabilities was made by Commissioner Handy and seconded by Commissioner Ayers to approve. All voted in favor
- 2) Office furniture purchase in FY20 was discussed. Commissioner Handy made a motion to approve the office furniture purchase as presented. Commissioner Sebald seconded the motion and all voted in favor.
- 3) The apiary located within the Town of Hebron has been issued a cease and desist order by Attorney Cox 6/17/19.
- 4) 506R North Main discussion indicated a special exception would be needed in order to operate a business on site. Attorney Steve Cox to send a cease and desist order.


