#### **Minutes**

## 2. Quote for Fencing.

There were two (2) quotes or bids for fencing at 208 North Main Street, which were:

1. Grasso

\$18,640.00

2. Long Fence

\$16,972.00

Not included in either bid were the vinyl slats that would go in the chain links for privacy. After some discussion, a Motion was made by Commissioner Handy and seconded by Commissioner Bradley to accept the Long Fence bid. The Motion was passed unanimously and the Chair voted Aye. After additional discussion, a Motion was made by Commissioner Handy and seconded by Commissioner Bradley to accept the Long Fence bid only if the fence was installed and invoiced before June 30, 2021 for budget considerations. This bid was essentially modifying or amending the prior Motion. The Motion was passed unanimously and the Chair voted Aye.

## 3. Water Tower – Site Location Update.

Commissioner Dwyer advised that he had talked with Pay O'Malley about the land. Mr. O'Malley wants to review the concept due to the fact that he has a commitment to sell a portion of the land to someone else. After he has reviewed the matter, he will get back in touch with the Town.

Commissioner Dwyer advised that he had spoken with the County and received approval for the County providing dumpsters. He was going to talk further to the County about waiving the tipping fees.

#### 2. The Fence

Clyde advised that he had told Long Fence that he would demolish the current fence along Lillian Street in preparation for the installation of the new fence.
