- 1. Jonathan Lemon of the Train Depot brought a letter from the Train Depot requesting assistance in the amount of \$4,000.00 for brickwork. After some discussion, Commissioner Hooper made a Motion to use \$4,000.00 from the ARPA Funds and give them directly to the Train Depot. After some discussion, the Motion was passed unanimously and the Chair voted Aye, with Commissioner Pick abstaining.
- 2. Commissioner Pick advised that at last night's Recreation Commission Meeting, they asked if Clyde Church of the Public Works Department could provide a truck for Touch a Truck and ERV on September 30, 2023. After some discussion, Commissioner Pick moved to allow Clyde to provide the equipment for the Recreation Commission. Commissioner Sebald seconded the Motion. After some discussion, the Motion was passed unanimously and the Chair voted Aye.
- 3. Commissioner Hooper asked when the work on the 208 North Main Street Public Building would be completed. He was advised that it should be completed by the end of the month.
- 4. Town Attorney Steve Cox pointed out that in the July/August 2023 issue of The Local, Volume 54, No. 1, as produced by MML, pictures of Commissioner Handy appear on pages 15 (Banner Cities), 23, 24, and 25, (all about the MML 2023 Summer Conference Recap) showing her tremendous involvement in MML.
